This release is intended to discharge Steele Canyon High School, Grossmont Union High School District, its students, teachers, other participants, officials, sponsors, advertisers, volunteers, guests, owners and lessees of the premises used to conduct the event and each of them, their officers, directors, agents all of which are referred to as “**Released Parties**” from all liability to the undersigned, my/our personal representatives, assigns, and heirs, including, but not limited to, death or damage to property, caused or alleged to be caused in whole or in part by the negligence or intentional acts of the Released Parties.
