Section A: Grant of Space

- Upon acceptance of this Vendor Contract and receipt of payment, St. Thomas the Apostle School and St. Thomas the Apostle Church will grant vendor the right to use the designated booth (space) at the St. Thomas the Apostle School Car Show, at 3774 Jackson Street Riverside, CA. 92503 on (Date) _____
- Cost of space will be: _____
- Refunds will only be returned with a two week notice of cancellation. After that, no refunds.
- Vendors will provide their own tables, chairs, and canopy or any other necessary tool/property to insure safety for food preparation including, adequate cooling as required to keep food fresh as needed to prevent spoilage or risk of food contamination.
- Vendors are responsible for area to be kept clean at all times. After show and before leaving the grounds, vendors are responsible to make sure any trash on their site is picked up and disposed of properly.

Section B: Laws and Permits

- Vendors must comply with all relevant local, state, and federal laws if applicable.
- Vendors are responsible for obtaining and paying additional licenses only if applicable.

Section C: Indemnification and Releases
