Vendors must stay for the entirety of the event. No early move outs will be allowed.

No food or beverages are to be sold at the booth.

Heritage Festival location: Tri-City Regional Park (2301 N. Kraemer Blvd, Placentia, CA 92870) at the intersection of Golden Ave. and Kraemer Blvd.

Vehicles must be out of the assigned vendor area AND booths completely set up by 9:00a.m.

No vehicles will be allowed to enter Tri-City Regional Park after 9:00 a.m.

Tri-City Regional Park is closed to all vehicle traffic between 9:00 a.m. and 3:30p.m., vendors are required to stay for the entire event.
